With reference to your letter dated May 3<sup>rd</sup>, 2015 concerning your inquires about the aforementioned investigation, kindly, be informed that:

- 1- The Investigating Authority agrees on considering the Ministry of Economy of Turkey as an interested party in this investigation.
- 2- Pursuant to Article (25) of the Regulation, hearing may be hold at the premises of the Investigating Authority for all interest parties to meet those parties with adverse interests, so that opposing views may be presented and rebuttal arguments offered, provided that they submit a written request includes specific reasons as to why they should be heard. Furthermore, the Investigating Authority will inform the Ministry of Economy of Turkey once a decision is taken to hold such a hearing, as it considered an interested party in this investigation.
- 3- Concerning your request to extend the time limit for unknown companies to make themselves known and to submit required information in section (8.a) included in the notice of initiation until May 21<sup>st</sup>, 2015, considering the strict time-table by which it is bound, the Investigating Authority agrees to extend the time limit until May 12<sup>th</sup>, 2015. However, the deadline for all companies (known & unknown) to submit the response to the exporter and producer questionnaire is June 3<sup>rd</sup>, 2015.
