The Embassy of Bosnia and Herzegovina presents its compliments to the Ministry of Foreign Affairs of the Republic of Turkey and has the honour to inform as follows:

The Food Safety Agency of Bosnia and Herzegovina proposed and the Council of Ministers of Bosnia and Herzegovina adopted a Decision on additional special import criteria for some food products and animal ware from some countries due to the risk of contamination by the aflatoxins (Official Gazette No.: 90/16 on December 2, 2016).

Regarding the import from the Republic of Turkey, products that are subject of above mentioned Decision are as follow:

Dry fig Tariff code: 0804 20 90 Nuts mix or dry fruits containing fig 0813 50; Paste of fig 2007 10 or 2007 99: Fig. prepared or canned, including mixtures ex 2008 99| ex 2008 97; Shell nuts (Corylus spp.) 0802 21 00t Hazelnut (Corylus spp.) 0802 22 00 Nuts mix or dry fruits containing hazelnut ex 0813 50 -Hazelnut paste ex 2007 10 jor 2007 99; Huzelnut: prepared or canned, including mixtures ex 2008 19 ex 2008 97; Hazelnut flour, powder and grits ex 1106 30|90; Hazelnut cut into pieces, slices and crushed ex 0802 22 00, 2008 19; -Hazelnut oil ex 1515 90 99: Pistachio shell 0802 51 00 Pistachio shell free 0802 52 00 Nuts mix or dry fruits containing pistachio ex 0813 50; Pistachio paste ex 2007 10 or 2007 99; Pistachio: prepared or canned, including mixtures 2008 19 13 2008 19 93, ex 2008 Pistachio flour, powder and grits ex 1106 30 90.

In order to Decision, every export of the above mentioned products must include results and analyses of the sample conducted by the relevant authorities of the country of the origin of the product or country of export, if it is different.

Additionally, in every case of export of above listed products to Bosnia and Herzegovina, products must have a Health Certificate, issued by Directorate General for Food and Control of the Ministry of Food, Agriculture and Livestock of the Republic of Turkey.
