The following communication, dated 19 May 2017, is being circulated at the request of the Delegation of Jordan.

In accordance with Article 12.1 (c) of the Agreement on Safeguards, and referring to Jordan's notification 12.1(b) WTO document (G/SG/N/8/JOR/10/Suppl.2-G/SG/N/10/JOR/10-G/SG/N/11/JOR/6/Suppl.2) dated 15/2/2017.

Jordan hereby notifies the Committee on Safeguards the issuance of Council of Ministers decision to impose a safeguard measure on the imports of "Aluminum bars, rods and profiles", under the tariff heading (7604) of the Jordanian Harmonized Tariff System except which is imported under subheadings (7604.211, 7604.101, 7604.212, 7604.291).

According to Jordan's legislation, the decision shall enter into force as of the publication of the decision in two daily newspapers, which is 15/5/2017.

1. Provide a precise description of the final measure

Imposing in addition to the applied tariff duty, a specific surcharge of JD 400 per ton, subject to annual liberalization of JD 50 per ton as in the schedule, as follows:

Duration	Value
15/5/2017 - 14/5/2018	400 JD/Ton
15/5/2018 - 14/5/2019	350 JD/Ton
15/5/2019 - 25/10/2019	300 JD/Ton
