The following communication, dated 2 August 2017, is being circulated at the request of the Delegation of Jordan.

In accordance with Article 9.1, footnote 2 of the Agreement on Safeguards, Jordan hereby submits its notification of the amended list of developing countries excluded from the imposition of the safeguard measure on Aluminum bars, rods and profiles.

The National Production Protection Directorate the competent authority at the Ministry of Industry, Trade and supply has analyzed the volume of imports of the product concerned based on the official statistics from Jordan Department of Statistics.
