RESOLUTION

MOSCOW

On the introduction of a temporary ban on imports to the Russian Federation of some kind of fuels

In accordance with articles 29, 47 and Annex 7 to the Treaty on the Eurasian economic Union of may 29 2014 in order to ensure the energy security of the Russian Federation and stabilize the situation on the domestic fuel market the Government of the Russian Federation decides:

1. Establish from the date of entry into force of this resolution until October 1, 2020 a temporary ban on the import to the Russian Federation of fuel types according to the list in accordance with the Annex.

This prohibition does not apply to:

for fuel transported in international transit traffic that begins and ends outside the territory of the Russian Federation, as well as fuel whose country of origin is the Russian Federation that is transported between parts of the Russian Federation through the territories of foreign States;

for fuel contained in technological tanks intended for its storage, water, air, railway or automobile vehicles, used for the purpose of operation EN route;

for fuel imported into the Russian Federation before the entry into force of this decree, in respect of which actions related to customs Declaration and release have not been performed;

for fuel transported by individuals for personal use.

- 2.Federal customs service shall ensure control over the implementation of the provisions provided for in paragraph 1 of this resolution.
- 3. The Ministry of economic development of the Russian Federation to notify in the prescribed manner of the Eurasian economic Commission on introduction of temporary prohibition referred to in paragraph 1 hereof.
- 4. To the Ministry of energy of the Russian Federation:

together with the Federal Antimonopoly service ensure monthly monitoring and control over the volume of production and supply of petroleum products to the domestic market in the Russian Federation;

together with the Ministry of economic development of the Russian Federation, the Ministry of industry and trade of the Russian Federation, the Federal Antimonopoly service and interested Federal Executive authorities, make proposals, if necessary, before July 15, 2020, to change the term of the measure provided for in paragraph 1 of this resolution.

5. Federal Antimonopoly service and the Ministry of energy of the Russian Federation, together with the highest Executive authorities of the subjects of the Russian Federation, should ensure that fuel markets are balanced and that fuel prices do not accelerate.
