Interested eligible bidders may obtain further information from the Accountant (Procurement), Ministry of Public Security, 14 Floor, Suhurupaya, Battaramulla.and inspect the bidding documents from the address given below from 09.00 a.m. to 03.00 p.m. on any working days except on Public & Bank Holidays from 20.08.2021 until 30.09.2021.
- 6. Bidders shall consider the requirement under the Public Contract Act No. 03 of 1987 and few important extraction of the act is as follows;

"any person who act as an agent or sub-agent, representative or nominee on behalf of any bidder, shall register himself and such public contract in accordance with the section 10 and shall furnish to the register the particulars required to be furnish under the section 6"

"Where any person is an agent, sub-argent representative or nominee for or on or behalf of a bidder, he shall first produce a certificate of his appointment as agent or sub agent, representative or nominee to the registrar before he registers himself and the Public Contract under this section.

Bidders are advised to present the registration certificate on or before purchasing the bidding document, according to the Public Contract Act no 03 of 1987, if relevant.

In additional to the above, bidder shall forwarded 15 Meters Khaki Uniform Material as samples for field testing & laboratory testing and shall pay Rs.80,000.00 of Non Refundable fee in cash, as sample laboratory testing charges ;

A complete set of bidding documents in English Language may be purchased by interested Bidders from the Procurements Branch, Ministry of Public Security, 14 Floor, Suhurupaya, Battaramulla., on submission of a written application to the Chief Accountant and upon payment of a non-refundable tender fee of Rs. 45,300.00 in cash from 09.00 a.m to 03.00 p.m on any working days from 20.08.2021 up to 30.09.2021. Only a single set of bidding documents will be issued for an institution.
- 8. Bids in duplicate (Original and Duplicate) shall be kept at the Tender Box placed at the Accountants (Procurement), Office of the Ministry of Public Security, 14 Floor, Suhurupaya, Battaramulla, at or before 11.00 hrs on 01.10.2021 Alternatively, Bids may be sent by the registered post to reach the above address before the closing time of bids. All late bids shall be rejected. Bids will be opened soon after closing, in the presence of the Bidders' Representatives, who choose to attend at the Conference Hall at the Ministry of Public Security. The representatives who will attend on behalf of the bidder should produce an authorized letter from the organization. Failure to submit an authorized letter will cause to not allow for participation in the bid opening.
- 9. Bids shall be valid until 31.12.2021 (91 days from date of bid opening)
- **10.** All bids shall be accompanied by a Bid Security at the amount indicated above and it shall be;
  - i. Issued by any Commercial Bank operating in Sri Lanka and approved by the Central Bank of Sri Lanka.
  - ii. In the form include in Section IV of the Bidding Documents.
  - iii. , In favors of Secretary / Ministry of Public Security, Floor 14, Suhurupatya, Battaramulla.
  - iv. Valid up to 29.01.2022 (119 days from date of bid opening)
- 11. The decision taken by the Ministry Procurement Committee (MPC) will be the final decision and the Purchaser reserves the right to make any amendments on Financial Regulations and Treasury Circulars issued periodically.
